I understand and acknowledge that the activity to be engaged with the rental of an inflatable unit(s) interactive amusement device, bring with it both known and unanticipated risks to myself and/or guests and/or participators. Those risks include but are not limited to falling, slipping, crashing, and colliding and could result in injury, illness, emotional distress, death, or property damage to myself and my guests and/or participators.

PARTIES: The Renter hereby engages Daryl Fun Bounce who agrees to furnish the items described above upon the terms and conditions set forth herein. **PAYMENT:** Full payment is due upon arrival at event, in the name of Daryl Fun Bounce.

TIMING AND FEES: The reserved rentals shall be delivered no later than 15 minutes before the requested start time unless both parties agree upon other arrangements.

Daryl Fun Bounce reserves the right not to perform outdoor engagements when, in Daryl Fun Bounce's judgment, weather conditions would be detrimental to the equipment and/or safety concerns for Renter. This includes but is not limited to wind, rain, or mud. A suitable indoor location should be reserved as an alternative site in the event of poor weather conditions.

SETUP AND OPERATION: The Renter should have at least 1 person of average strength per inflatable at all times. This person (operator) will be responsible for operation of the ride. Renter is responsible for enforcing posted and below listed rules. Instructions for safety and operation will be reviewed at the time of setup.

Rules for use of moonwalks and slides

- 1. All occupants remove their shoes before entering unit.
- 2. All occupants are assisted when entering and exiting the unit.
- 3. Occupants are sorted by size. Only occupants of the same size should be allowed in the unit at the same time (for the protection of smaller event-goers).
- 4. Occupants remove glasses and dangling jewelry.
- 5. No climbing, hanging or pulling on the nets, sides, top, or back of the units.
- 6. No roughhousing or horseplay in, on or around the unit.
- 7. You may only use steps to climb to the top of the slide, and only slide down feet first, one person at a time.
- 7. At any given time, Bouncer/Moonwalk capacity of the occupants is never to exceed:

Small Children: 8 Medium Children: 5 Teens or Adults: 3

AT NO TIME SHOULD THE EQUIPMENT BE LEFT UNATTENDED!

FOOD, DRINKS, CANDY, ANIMALS, SHOES, Silly String or SHARP OBJECTS are NOT allowed in the rentals at any time. The operator is responsible for ensuring that the size and number of persons entering the inflatable does not exceed the maximum. Rentals that are set up on hard surfaces such as concrete or asphalt must be closely watched to prevent their moving. If the equipment moves off the provided tarp, damage or staining may occur on the bottom of the unit.

If the Renter chooses to deflate the equipment prior to the arrival of the pick-up attendant, it must be re-inflated before it is packed up. The unit will be inspected and receive a preliminary cleaning before removal.

The items rented/listed above shall be inspected by Daryl Fun Bouce and renter upon delivery to assure there are no issues. There are no refunds.
